Subject: Update on open ALAC advice items

Dear Jonathan,

As part of our efforts to transition to the new approach for Board consideration of advice, we've gone through the open ALAC advice items with a fine comb. The objective of this review has been to:

1. Ensure the most recent status update is provided, including details on expected next steps and timing;
2. Update the status descriptions to align with the new terminology (e.g. change from deferred to pending);
3. Consider if these open advice items can be transitioned to the new approach or closed out, if the item is no longer current or overtaken by events.

You will find the result of this effort below. Once the transition to the new approach is complete, the relevant internal project teams (IPTs) will be responsible for providing regular updates on the status of consideration and/or implementation (for advice items that have been approved by the ICANN Board) for new advice items.

This process is underway and aims to complete at the latest by the end of 2023.</p>
<p>Joint Statement - ALAC & GAC Enabling Inclusive, Informed and Meaningful Participation at ICANN: A Joint Statement by ALAC and GAC</p> <ul style="list-style-type: none"> • Rec: 1 • Rec: 2 <p>(2Nov2017)</p>	<p>Phase 4 Implement</p>	<p>The issue of engagement and tools, including features of ITI, were discussed during the Board Meeting with the ALAC on 13 March 2023 during ICANN76.</p> <p>On 15 March Sally Newell Cohen (SNC) met with ALAC Chair Jonathan Zuck (JZ), ALAC Member Joanna Kulesza and Alan Greenberg (AG) on the next steps for the Joint ALAC-GAC Statement Enabling Inclusive, Informed and Meaningful Participation at ICANN. The ALAC noted that the ALAC and GAC are looking for ICANN org, at minimum, to create summaries of documents (aimed at helping newcomers) and to document updated versions of a report if/when an item is updated to ensure the most recent version is being used.</p> <p>On 18 May, SNC held a follow up meeting with JZ and AG ahead of an ALAC meeting with the GAC. JZ stated he would like a means to enable newcomers to get engaged in At-Large quickly. It was agreed that a primer, a simple intro to a topic or issue, would be preferred over an executive summary. An action item was for the ALAC and GAC to prioritize their top 10 priority topics to focus on. ALAC and GAC engagement with ICANN org is expected to continue on this topic with the aim to finalize the conversation by the</p>

		end of 2023. The ALAC is considering identifying topics for the 10 primers to be developed by ICANN org. The aim is to have the ALAC/GAC agree either at ICANN78 or shortly thereafter.

However, this does not preclude the ALAC from resubmitting this Advice, or new Advice on this topic when the ICANN Board unpauses its consideration of the SSAD policy recommendations.</p>
