We will operate closed .brand registries so there will be no effect on competition in the domain name market itself. \r\n\r\nHowever, the addition of IDN languages will have a positive effect on competition in the global marketplace by providing for more efficient navigation for end users of different languages.\r\n\r\n

How would you define the markets in which your proposed Registry Service would compete?:

The service itself will not compete as we are operating closed .brand registries.\r\n

What companies/entities provide services or products that are similar in substance or effect to your proposed Registry Service?:

The Italian ccTLD registry, Registro.it, and the Polish ccTLD registry, NASK, currently provide Italian IDNs under .it and .pl, respectively.\r\n

In view of your status as a registry operator, would the introduction of your proposed Registry Service potentially impair the ability of other companies/entities that provide similar products or services to compete?:

No. In fact, the opposite is true: our provision of Italian IDNs might show other registries that there is demand by end users for navigation in Italian, encouraging them to introduce similar services.\r\n

Yes \r\n\r\nFerrero has contracted with Neustar to provide the technical backend services associated with these three TLDs. Consequently, Neustar will provide the technical functionality to allow for Italian character domain names.\r\n\r\n
