I. INTRODUCTION

- 1. Afilias has calculated its total fees, expenses, and costs (for short, "fees and costs") for the IRP, as well as the fees and costs specifically associated with (i) the participation of *Amici* and (ii) the EmergencyInterim Measures phase. This Annex explains how we have calculated each of those categories of fees and costs. The schedule includes fees and costs from 16 June 2020 through 30 September 2020.
- 2. For the purpose of this methodology, "fees" refers to those amounts incurred for legal services in relation to the IRP, "expenses" refers to the amounts related to the provision of those legal services, and "costs" refers to all other amounts in relation to the IRP.
- 3. To calculate the fees and costs, Dechert LLP and Constantine Cannon LLP each identified their billing records for each timekeeper who billed time or expenses for the IRP. The included records are for fees and expenses as already paid through July 2020 and as recorded for August and September 2020.¹ These records were carefully reviewed to ensure that they contained only billing entries directly related to the IRP.
- 4. To calculate the costs, we have separately identified invoices in relation to ICDR services, the EmergencyPanelist, the Procedures Officer, the Panel, TrialGraphix, and transcription services, as well as those in relation to Afilias' experts. These include amounts as paid through July 2020 and invoiced through September 2020. They do not include amounts that have not yet been invoiced. They also do not include amounts from Barkley Court Reporters and TrialGraphix Trialanywhere, which have not yet been invoiced.
- 5. The following sections describe the methodology used to calculate (i) Afilias' total fees and costs, (ii) Afilias' fees and costs in relation to the *Amici* participation, and (iii) Afilias' fees and costs in relation to the Emergency Interim Measures phase.

Please note that the Constantine Cannon LLP fees, expenses, and costs for September 2020 are not included in these calculations. Afilias will provide Constantine Cannon's September 2020 fees, expenses, and costs together with its reply to ICANN's submission on costs.

II. TOTAL FEES AND COSTS

6. The total fees and costs set out in the schedule include fees and expenses recorded from **16 June 2018**, when Afilias learned that ICANN had rejected its .WEB application, through **30 September 2020**. The total fees and costs also include costs in relation to ICDR services, the Emergency Panelist, the Procedures Officer, the Panel, and Afilias' experts.

III. FEES AND COSTS FROM AMICI PARTICIPATION

- 7. The fees and costs associated with the participation of *Amici* include fees and costs recorded in relation to the Procedures Officer, Phase I, and Afilias' Response to *Amici*. Although Afilias incurred fees and costs during the merits hearing and post-hearing phases due to the participation of the *Amici*, we have conservatively excluded those amounts from this category.
- 8. We have applied a time-based methodology, whereby fees and expenses from time periods specified below are used to calculate the fees and expenses for each of the three elements. We have reviewed the individual time entries to verify that the specified time periods effectively cover the relevant fees and expenses.
- 9. *First*, the fees and costs for the Procedures Officer phase are based on fees and costs recorded from the filing of the Requests by Verisign and Nu Dot Co to Participate on *11 December 2018* through the Procedures Officer's Order on ICANN's Request for Correction on *31 March 2019*.
- 10. However, this phase overlaps with the Emergency Interim Measures phase, for which fees and costs are separately calculated, as well as with the general IRP (including preparation of the Amended Request for IRP and the constitution of the Panel), not separately calculated. To exclude the fees and costs not associated with the Procedures Officer phase, we have evenly allocated fees and costs across work streams active on any given day. Thus, Afilias' total fees and costs from 11 December 2018 to 21 March 2019 are divided by three to calculate the Procedures Officer phase fees and costs—to account for the simultaneous ongoing work on the Emergency Interim Measures phase and the general IRP.

- 11. **Second**, the fees and costs for Phase I include all fees and costs recorded following the constitution of the Panel on **9 August 2019**² through Afilias' Rebuttal to ICANN's Time-Bar Defense on Rule 7 on **3 December 2019**.
- 12. **Third**, the fees and costs for Afilias' Response to *Amici* include all fees and costs recorded following the *Amici* Briefs on **26 June 2020** through Afilias' Response to *Amici* on **24 July 2020**.
- 13. The fees and costs associated with the participation of *Amici* also include costs in relation to the Procedures Officer and the Panel's Phase I Decision (specifically the amounts ICDR invoiced on 13 August and on 4 November 2019 for Panel compensation). No costs associated with Afilias' experts are included in this category.

IV. FEES AND COSTS FROM EMERGENCY INTERIM MEASURES

- 14. The fees and costs associated with the Emergency Interim Measures phase is based on fees and costs recorded from **14 November 2018**³ to **14 May 2019**⁴. They do not include any fees and costs in relation to Afilias' experts. We have reviewed the individual time entries to verify that the specified time period effectively covers the relevant fees and costs.
- This phase overlaps with the Procedures Officer phase from 11 December 2018 to 31 March 2019 as well as with the general IRP (again, including preparation of the Amended Request for IRP and the constitution of the Panel). To exclude the fees and costs not associated with the Emergency Interim Measures phase, we have evenly allocated fees and costs across the work streams active on a given day as follows:
 - a. From 14 November 2018 to 10 December 2018, Afilias' fees and costs are divided
 by two to calculate the Emergency Interim Measures phase fees and costs—to

This final date for substantial activity on the Emergency Interim Measures phase is identified from time entries. However, it conservatively is prior to ICANN's abandonment of its attempt to delegate .WEB during the pendency of the IRP.

- account for the simultaneous work on the general IRP.
- b. From 11 December 2018 to 31 March 2019, Afilias' fees and costs are divided by three to calculate the Emergency Interim Measures phase fees and costs—to account for the simultaneous work on the Procedures Officer phase and the general IRP.
- c. From 1 April 2018 to 14 May 2018, Afilias' fees and costs are divided by two to calculate the Emergency Interim Measures phase fees and costs—to account for the simultaneous work on the general IRP.
- 16. The fees and costs associated with the Emergency Interim Measures phase also include costs in relation to the Emergency Panelist. No costs associated with Afilias' experts are included in this category.
