

1. Procedural Order No. 4 (Schedule) – Procedural Order No 4 (Scheduling) (“PO 4”) was issued on 14 July 2022 and the parties stipulated to various extensions with respect to the Timetable therein. On 27 April 2023, Respondent ICANN provided notice that the ICANN Board would be considering a Resolution and Rationale regarding the .GCC application. Thereafter, the parties reported that they met and conferred regarding the impact of the ICANN Board’s 30 April 2023 Resolution and Rationale and agreed to vacate all dates set in PO 4. The parties further agreed that they meet and confer regarding next steps following posting of the 30 April 2023 Board Meeting Minutes and Board briefing materials. The Tribunal agreed to the parties’ stipulations and, accordingly, by email correspondence dated 30 May 2023 all scheduled dates were vacated.
2. Agreement on Schedule: The parties reported on 21 November 2023 that they had reached an agreement on scheduling for this IRP and, on the same date, the Tribunal confirmed that the parties’ stipulated schedule was acceptable.
3. Timetable: Accordingly, the parties stipulated schedule, as reflected in the attached Timetable, is now in effect.
4. Extensions: The parties remain free to stipulate in writing to reasonable extensions, other than as to hearing-related dates, without approval of the Tribunal.

The parties are requested to submit any proposed adjustments, corrections or objections to this Order within five (5) business days of transmittal of this Order.
