

Dear Members of the Governmental Advisory Committee of the ICANN,

I have the pleasure to address to you in order to confirm the submission of the candidature of the Argentine representative, before the Governmental Advisory Committee (GAC) of the ICANN, Dr. Olga Cavalli for the presidency of the GAC for the period 2018-2019, in the elections that will take place during the 60th ICANN Meeting (Abu Dhabi, October 9, 2017)

The aforementioned candidature counts with strong support of other GAC representatives. In fact, during the 59th ICANN Meeting, held in Johannesburg, Dr. Olga Cavalli's candidature was promoted by the Republic of Peru.
