Dear Danilo Bettini,

Please be advised that as of 1 March 2018, Fan Domains Ltd.'s ("Fan Domains") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 19 March 2015 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 30 March 2018, 29 days from the date of this notice.

The termination is due to Fan Domains' failure to timely cure the breaches by 26 February 2018 and 27 February 2018 as set forth in ICANN's notices of breach of RAA dated 5 February 2018 and 6 February 2018. As of 1 March 2018, the following breaches remain:

1. Fan Domains' failure to provide Registrar Services, as required by Section 3.1 of the RAA;
2. Fan Domains' failure to provide and maintain accurate and current information as specified in the Registrar Information Specification ("RIS") and to notify ICANN within five days of any changes to such information, as required by Section 3.17 of the RAA;
3. Fan Domains' failure to provide an interactive webpage providing free public query-based access to up-to-date data concerning all active registered names sponsored by Fast Domains for each top-level domain ("TLD") in which it is accredited, as required by Section 3.3.1 of the RAA;
4. Fan Domains' failure to escrow gTLD registration data, as required by Section 3.6 of the RAA;
5. Fan Domains' failure to maintain and make available to ICANN registration data and records relating to dealings with the Registered Name Holder ("RNH") of the domain name <livemusic.fans>, as required by Sections 3.4.2 and 3.4.3 of the RAA;

6. Fan Domains' failure to permit the Registrant at Expiration ("RAE") to renew an expired domain name registration, as required by Section 2.2.5 of the Expired Registration Recovery Policy ("ERRP"); and
7. Fan Domains' failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Please see the chronology below for additional details.

Fan Domains is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 30 March 2018. Please remove all ICANN trademarks, name and logo from Fan Domains' website and business materials that have been licensed to Fan Domains under the terms of that Specification by 30 March 2018.

Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by Fan Domains.

ICANN will follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure"). Consistent with the Procedure, please designate a bulk transfer recipient by 8 March 2018 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Fan Domains has current and past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
